Description of the Defect : Wiring of fuse/circuit breaker and box at the hitch area between the battery and the converter was not wired per engineering drawing, The 30amp fuse was bypassed, - created unprotected circuit

While investigating a field concern with a 2017 Launch (H2JZ5150), Engineering performed inspection of a 2018 unit (K2UA5068) and noted void of circuit protection between the battery and the converter. Engineering confirmed that the wiring was not as specified on the Engineering print. Inspection of current product on line found they too lack the circuit protection between the battery and the converter. Operations informed and commenced to wire per Engineering print on 5-1-2019. Engineering continued with research into this matter. 9-4-2019 CPAC teamed reviewed Details of the Engineering investigation and voted to escalate to Safety Committee with recommendation of a recall. 9-26-19 Safety Committee Confirmed recall required
