Description of the Safety Risk: Without a seat base cover, the opening in which the integrated backup

battery is located can be exposed by moving the seat forward. An object containing conductive material, such as metal, could be unintentionally dropped into the opening and make contact with the poles on the battery. Were this to occur, it could result in a short circuit, increasing the risk of a

fire.
