Description of the Defect: According to the Chevrolet Recall Notice 19V644: "General Motors has decided

that certain 2019 model year Chevrolet Express and GMC Savana vehicles may fail to conform to S7.3 of Federal Motor Vehicle Safety Standard (FMVSS) 208, Occupant crash protection. In these vehicles, the seatbelt-unfastened telltale will not illuminate for approximately five seconds after the ignition is moved to the on or start position. There is no impact to the vehicle's seatbelt systems,

and the telltale will function normally after the five second delay."

FMVSS 1: 208 - Occupant crash protection

FMVSS 2: NR

Description of the Safety Risk: According to the Chevrolet Recall Notice 19V644: "During the five-second

delay, the telltale will not alert the driver that the

driver's seatbelt is unbuckled, however, there is no delay in the activation of

seat belt warning chimes."

Description of the Cause: According to the Chevrolet Recall Notice 19V644: "A software change

implemented for 2019 model year Chevrolet Express and GMC Savana vehicles contains an error that inhibits the activation of the telltale for five seconds after

vehicle startup.

On October 11, 2019, Forest River was able to identify population per the VIN listing received from General Motors.

ON 2/3/2020 Amended recall to reflect thay GM will be issuing quarterly reports to NHTSA ON 3/2/2020 During an internal audit it was determined that incorrect verbiage "Ford" was used in "Identify the Remedy" should be GM. Amended to reflect this change.

On 3/26/2020 Amended recall to reflect the new increased population of vehicles. NHTSA sent an inquiry to Forest River regarding Forest River Recall 19V736 and the scope of General Motors vehicles. Forest River conducted a review using the CarFax VIN Recall Lookup Tool and identified vehicles affected under General Motors Recall 19V644 (Forest River Recall 19V736)." Forest River will notify all consumers immediately.
