August 29, 2019 research of trailer lighting requirements and what each model trailer had installed on the trailer began. Discussion between groups and product safety and compliance groups at Vermeer Corporation took place and data was gathered and passed back and forth during meetings.

October 21, 2019 compiled list of affected models that did not meet the requirements and the population of machines involved.

November 5, 2019 decision to initiate recall for non-reflex reflector trailer lighting

Description of Remedy:

Description of Remedy Program: A field campaign will be initiated to install separate reflex reflectors red with an SAE (A) marking will be installed on the sides and rear of each of the affected machines. Added white conspicuity tape on tanks to show outline. Customers and dealers will be reimbursed for the labor of installing the reflex reflector decals.

How Remedy Component Differs The reflex reflectors with an SAE (A) marking will be present on the side

on the rear of the tank. Adding additional red/white conspicuity tape to

sides to mark at least 50% length of the trailer.
