brake warning light in the vehicle instrument cluster. The transfer of passengers between school buses in potentially hazardous conditions would

increase the risk of injury.

Description of the Cause: The potential of a deformed brake switch mounting bracket is most commonly

Chronology:

November 2012 – Blue Bird released recall 12V538 to update the brake switch mounting bracket on the initial 452 buses equipped with the Ford brake switch. At the time of this recall, very limited usage experience had been obtained and so in the absence of field data and in an abundance of caution, the decision was made to improve the brake light switch bracket to the mounting bracket design that was utilized through April 2019. February 2019 – Based on a NHTSA inquiry, Blue Bird initiated a detailed analysis of the Ford brake switch mounting bracket warranty claims and service reports. Blue Bird has received four reports related to deformed brake switch mounting brackets. During this analysis, Blue Bird determined that the Ford brake switch warranty claims and service records could be related to potentially bent mounting brackets. The initial installation of a new Ford brake switch into an in-service bus would result in a new zero position for the brake switch which could correct for any mounting bracket deformation.

April 2019 - Blue Bird implemented a Bendix redesigned mounting bracket assembly into production as a

continuing product improvement.

May 2019 – Blue Bird requested that Bendix develop a redesigned mounting bracket for fielded units. June 2019 – Bendix provide preliminary information on a redesigned mounting bracket for fielded units. October 2019 – Blue Bird confirmed that a deformed brake switch mounting bracket could result in a brake warning light in the vehicle instrument cluster.

November 2019 – Blue Bird initiated a recall campaign out of an abundance of caution given that the possibility exists that a school bus driver may be required to pull the vehicle over immediately to an unsafe location based on an illuminated brake warning light in the vehicle instrument cluster.

Description of Remedy Program: Blue Bird will provide the affected dealers and owners with instructions

on how to remove the existing brake switch mounting bracket and install the provided redesigned mounting bracket. Blue Bird will also provide a new Ford brake switch as part of the kit to ensure that the switch has the correct set point after the new brake switch mounting bracket is installed.
