On November 15, 2019, Forest Rivers Office of Corporate Compliance ("OCC") received an email questioning the exclusion of Glaval Bus from Forest River Recall Number 19V-555. Upon investigation, it was found that Forest River was only notified of product used in the Starcraft models. Further investigation into the use of the suspect roof hatch revealed that Glaval Bus had used the affected roof hatch. Using production records, Forest River was able to identify those vehicle affected.

On 12/10/2019 it was found during an internal audit that 3 VINs were sold to Canadian owners. Resent NOD to TC and filed amendment with NHTSA. Population US 356 CANADA 13
