MBAG began the development of US and Canadian airbag modules for the new model year E-Class AMG (platform 213) with a new steering wheel in September, 2018. As is customary, early production vehicles were released with the expectation that certification validation would occur and apply to the vehicles or that the vehicles would be updated with new airbag hardware and software.

During a routine plant audit, it was determined that certain early production vehicles were released from the Vehicle Processing Center without receiving the updated certified airbag hardware and software. The affected vehicle population was identified and a decision was made to conduct a safety recall on November 29, 2019.

#### **Description of Remedy:**

Description of Remedy Program: As a precautionary measure, an authorized Mercedes-Benz dealer will

check the driver airbag module and software on the affected vehicles, and

replace the airbag and update the software, if necessary.
