Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2020 Springdale Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Reason for this recall

It has been decided that the vehicles in the recall population fail to conform to the requirements of Part 567, "Certification." The vehicles subject to this recall may have been manufactured with the incorrect information on the Federal Identification Tag. The tag indicates the rim size is 15x6, tire size is ST205/75R14D @ 75 psi. The correct rim size is 15x6, tire size is LT235/75R15D @ 65 psi. This does not affect the GVWR just wheel data. An incorrect label may lead to unintentionally overinflating the tires, increasing the risk of a crash. The vehicles included in the recall are:

2020 Springdale Travel Trailers, Models 1700FQ, 1750RD, 1760BH, 1790FQ, 1800BH Serial Number Range: LW103096 - LW103297

Our records indicate unit(s) sold or in your present lot inventory fall within this range, which will require immediate preventative action. **Important:** If some of the units are still in your inventory, Federal Law requires you to complete the recall service on those units before retail delivery.
