Descriptive Information : The recall population was determined based on VIN information obtained from Spartan Motors USA regarding their recall number 19017 (19V-674) This only affects three units that were manufactured by Maintainer Custom Bodies.

Description of Defect :

Description of the Defect : Vehicles equipped with a pneumatically controlled automatic tire chain system, may fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 121, Air Brake System. More specifically, these vehicles may fail to meet section 5.1.2.3. of the standard. The service air reservoir system may not be pressure protected where the control line for the automatic tire chain system is connected.

FMVSS 1 : 121 - Air brake systems

FMVSS 2 : NR

Description of the Safety Risk : If control line were to become severed, the service reservoir system may suddenly lose air.

Description of the Cause : A pressure protection valve was not specified to be installed when the control line would be plumbed in the system 1 and system 2 air reservoirs.

Identification of Any Warning that can Occur : A low air audible and indicator will activate when the air pressure reaches a certain level.

Chronology :

Through investigation of recall 19V-360 we learned of recall 19V-674. Information we requested and received from Spartan Motors USA on 12/13/19 of recall 19V-674 which indicated that the original notification emailed to Maintainer Custom Bodies was sent to an undeliverable email address that was deactivated on 3/06/19.

Description of Remedy :

Description of Remedy Program : Refer to Safety Recall Report 19V-674
Maintainer Custom Bodies will issue an owner notification letter to two of the units in this population. The 3rd unit is still in possession of Maintainer Custom Bodies and will be inspected and/or repaired before shipment. Spartan will make arrangements to have dealers inspect the routing of the control line to determine if it is pressure protected or tied into the auxiliary air reservoir which is pressure protected. If the control line is not pressure protected, it will be rerouted and tied into the auxiliary air reservoir. Failed air lines would likely have been covered through warranty.
