- During the week between December 9, 2019 and December 16, 2019, FCA Italy inspected the stock of calipers in both the plant and warehouse and calipers installed on vehicles to determine that some calipers left the plant's control.
- As of December 16, 2019, FCA US has not identified any CAIRs or field reports potentially related to this issue.
- As of December 16, 2019, FCA US has not identified any warranty reports potentially related to this issue.
- As of December 16, 2019, FCA US is not aware of any accidents or injuries potentially related to this issue.
- On December 16, 2019, FCA Italy determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

#### **Description of Remedy:**
