Description of the Defect: McNeilus was notified by its supplier that it identified an issue during quality

testing where certain ring gear carriers were identified as having been produced outside of specification and have cavities locally in the area of the

toothing. .

Description of the Safety Risk: If cavities are present in the ring gear carriers, they can lead to the premature

failure of the drum transmission which would cause the drum to stop rotating unexpectedly. If the drum stops rotating, this may cause concrete to spill

onto the road surface while driving, increasing the risk of a crash.

Description of the Cause: According to ZF there are gear carriers that deviate from the specifications.

The affected ring gear carriers have cavities locally in the area of the toothing. If Drum transmission fails, under certain scenarios driving up grades, could

result in discharge of concrete from the drum. This could cause a hazard with

February 2020- McNeilus was notified by its supplier ZF that ZF identified that certain drum transmissions were produced out of specification and may cause premature failure of the transmission. McNeilus launched an investigation based on ZF's notification and isolated the part numbers identified by ZF. McNelius determined no completed vehicles had been shipped to customers with affected parts. Only customers that ordered replacement parts in a certain time frame that have affected serial number on the list are affected.

Description of Remedy:

Description of Remedy Program: The remedy consists of inspecting drum transmissions to see if unit falls into affected serial number range. If drum transmission falls into suspect serial number range, the drum transmission will be removed and replaced with a known good transmission that meets all specifications. The inspection and replacement will be performed by the customers own qualified service technicians at no cost to the owner.

How Remedy Component Differs The serial number range on the remedy component is different than the

Identify How/When Recall Condition After receiving ZF's notification, McNeilus sorted through its inventory and was Corrected in Production: vehicles that were ready to ship and in process of being built to search for suspect serial numbers on drum transmissions. The plant completed their search and found and removed any affected components. All vehicles that were found in the suspect range were replaced with known good drum transmissions before they were shipped to customers. Only parts sent to customers in the field through service parts were affected by the suspect serial number list.
