Chronology:

In mid-February, 2020, based upon an internal review of motorcycle accessory parts, BMW became aware that certain dealer accessory color-specific brake fluid reservoir covers produced for the US market could have been released that may not fully conform to FMVSS 122 Section 5.1.9(d).

A review of regulatory requirements, and the language contained on the covers, confirmed that potentially affected dealer accessory brake fluid reservoir covers may not fully conform to FMVSS 122 Section 5.1.9(d). Aftersales accessory records were reviewed to determine the number, and production date range, of potentially affected covers.

On March 12, 2020, BMW decided to conduct a voluntary non-compliance recall.

Description of Remedy:

Description of Remedy Program: The brake fluid reservoir cover will be replaced.

Owners will be notified by First Class mail and instructed to visit an authorized BMW motorcycle dealer to have the remedy performed for free. If this condition were to occur prior to this recall, the remedy would be covered by the BMW Motorcycle Parts Warranty program. Therefore, reimbursement for a pre-notification remedy re Part 573.13 and Part

577.11 is not necessary.
