IMPORTANT SAFETY RECALL

RECALL NO. 20E041

Dear Valued Code 3 Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Code 3 has decided that certain 7 x 9 Stop-Tail-Turn-Reverse All-in-One LED Lamps, Part No. 79STTRBZ, fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 108, *Lamps, reflective devices and associated equipment*. We are initiating this voluntary safety recall to address this issue. Our records indicate that you may have purchased one of these products.

What Products are Involved?

This recall involves Code 3 7 x 9 Stop-Tail-Turn-Reverse All-in-One LED Lamps, Part No. 79STTRBZ. These lamps were sold as original and replacement equipment for use primarily in emergency vehicles. The recall covers all products with this part number.

What is the Problem?

Recent quality testing conducted by Code 3 indicated that the subject lamps may exceed the maximum permissible candela levels specified in Federal Motor Vehicle Safety Standard (FMVSS) No. 108 at certain test points. The increased photometric intensity may adversely affect the vision of following drivers, increasing the risk of a vehicle crash.

What should you do?

Please contact Code 3 at (314) 426-2700 or c3_orders@code3esg.com to obtain a filter kit (Part No. CZ0199) free of charge. Installation of the filter kit will ensure that the lamps perform within the permissible photometric intensity ranges. Kits are currently available.
