Description of the Defect : Due to a process change at the supplier in effect during the stated production period, a pivot hole on the base component of some of these products may be out of position, resulting in less engagement between the T-latch and the base. This condition, if present, can prevent the upper moveable jaw from locking securely in the closed position.

Description of the Safety Risk : If the T-latch engagement is sufficiently reduced, there is a risk of opening and separation of the trailer from the towing vehicle, increasing the risk of a crash.

Description of the Cause : Manufacturing change (location of hole) by the fabricating manufacturer.

Chronology :

July 30, 2020: Horizon Global received a report that the Pintle jaw on a P/N 74117 became unlatched when the jaw was closed with the safety pin installed, causing the trailer to partially separate from the towing vehicle. (The safety chains prevented a complete separation.) The incident caused minor damage to the bumper of the towing vehicle.

July 30, 2020 – August 31, 2020: Horizon Global initiated an investigation to determine the cause of the unlatching. As this issue was being investigated, Horizon received a second report on Aug 13, 2020 of a similar unlatching (with no property damage). Horizon worked closely with the supplier to evaluate the product and manufacturing process to identify the potential cause(s) of the unlatching. During the course of the investigation, it was determined that Jingco's subcontractor implemented a change to the drilling process in October 2019 that caused the drill hole to move out of position by 1.5mm. Our investigation revealed that the subcontractor reversed this change as of May 7, 2020, with the last shipment to Horizon prior to such reversal being on or about April 2020.

September 1, 2020: Based upon the findings of the investigation team, Horizon Global leadership decided to conduct this safety recall to address this issue.

There have been no reports of accidents or injuries related to this condition.

Description of Remedy :

Description of Remedy Program : Horizon will coordinate with dealers and distributors to identify and notify purchasers of the affected products. Horizon will replace affected products free of charge. For P/Ns 4204, 63010, 63011, & 63012, affected products will be confirmed by the date code marked on the product. For P/Ns 74115, 7411533, 7411542, 74116, 7411633, 741161142, 74117, 7411733, & 7411742, affected products will be identified based upon date and place of purchase.

All of the subject products remain under the manufacturer's warranty. Therefore, pursuant to 49 CFR 577.11(e), Horizon Global requests an exemption from the reimbursement plan requirements.

How Remedy Component Differs from Recalled Component : Replacement (remedy) parts were manufactured with the hole in the correct location.

Identify How/When Recall Condition was Corrected in Production : On May 7, 2020, the supplier reversed the process change that caused the issue and implemented other improvements to the drilling process. Specifically, the drilling fixture was improved by increasing the limit block, which ensures the correct location of the hole.

Description of Recall Schedule : Horizon Global will work with dealers and distributors to identify and notify known purchasers of affect products. The timing of owner notification will depend upon receipt of owner contact information from Horizon's distributor/retailer customers.
