## **Description of Defect :**

Description of the Defect :	Although the testing by the independent laboratory confirmed that this Product meets the advertised load capacity when used as described on the Product's warning label, Summit Racing experienced a more than de minimis increase in warranty or quality returns relative to this Product. The testing and analysis of the Product, and the further inspection of the Product, reflect that there appears to be a material risk that the ratchet bar may fail during use of this jack stand which would allow the vehicle to fall without any warning, with the potential to injure persons near or under the lifted vehicle.

Description of the Safety Risk :	Should the unit experience a failure of the ratchet bar the vehicle will drop suddenly. The type of failure presents an opportunity for vehicle, property, and/or personal harm to occur.
Description of the Cause :	Testing did reveal a failure mode consistent with customer feedback (fractured ratchet bar) when the load was placed on one lug of the ratchet bar saddle. While testing with a centrally located load distribution resulted in no failure, it is possible that the unit may fail when centrally loaded as a result of previous misuse.
÷ 0	Visual inspection of the ratchet bar may confirm the presence of a fracture, but it is unlikely that any warning signs will be present before the point of failure.
