DEFECT/NONCOMPLIANCE:

On certain travel trailers, the emergency trailer breakaway switch may not work properly when the pin is pulled. If the trailer separates from a tow vehicle, the trailer brakes would not self-apply.

If the trailer breakaway switch does not work properly, there could be an increased risk of a crash.

SERVICE PROCEDURE:

Dealership Service Department Service procedures for to replace the breakaway switch is included with this notification.
