On February 4, 2020, OCC began a thorough review of all warranty claims and customer complaints pertaining to spare tire U-bolts from January 1, 2019 through February 4, 2020. On February 7, 2020, OCC finished the in depth review of warranty claims and customer complaints. OCC found a total of 16 failures of the spare tire carrier U-bolts. These failures began on October 31, 2019 and the last was received on January 23, 2020. OCC identified vehicles outside of the scope erroneously included in the original scope. The scope and manufacturing dates remain the same, the vehicles affected lowers in count.

On 12-18-19, Forest Rivers' Surveyor Plant notified the Corporate Quality Control and Office of Corporate Compliance of incidents where the National Sales Spare Tire Carriers' U-Bolt had broken during installation. The same day, OCC reached out to the supplier asking for information. At this time, OCC and the mfg. plants were unaware of any U-Bolt failures that were out of Forest Rivers control, however, We did initiate monitoring On 12-30-19 and 1-6-20, OCC continued to ask the supplier for information concerning the U-Bolts and if the supplier was able to tie the in-plant failures to a specific "lot". Without any failures in the field and isolated to the mfg. plant, OCC continued monitoring. On 1-15-20 the supplier responded to OCC indicating that they have not seen any warranty claims over the course of 2019. The supplier indicated they were conducting audits of the spare tire installation at other Forest River mfg. facilities. On 1-20-20 OCC asked the supplier for a listing of all Forest River mfg. plants they sold the spare tire carrier and U-bolts too. On 1-23-20, OCC was made aware by Forest Rivers' East to West mfg. plant of a single spare tire carrier U-bolt failure on a vehicle in transport to a dealership. On 1-29-20, OCC was made aware of another single failure on a vehicle in transport

to a dealership. On 2-4-20, OCC was made aware by Forest Rivers' East to West mfg. plant of a single failure on a vehicle in transport to a dealership. Corporate Quality Control issued an internal Product Notice to all Forest River mfg. plants advising the plants to inspect their inventory of spare tire carrier U-bolts and directed mfg. to change the U-bolts with new replacement U-bolts if any were found in inventory. OCC began a review of all warranty claims and customer complaints pertaining to spare tire U-bolts. On 2-7-20, OCC completed the review, a total of 16 failures were found. On 2-7-20, Forest Rivers' Corporate Recall Committee voted to recall.
