Description of Defect:

Description of the Defect: In certain rare circumstances, the fuel pump service cover can deflect and put

pressure on the flow nozzle on the filter flange of the fuel pump. This can result in hairline cracks potentially leading to fuel seepage and fuel odor.

Description of the Safety Risk: Fuel leakage in the presence of an ignition source may cause the risk of fire.

Description of the Cause: Under high load, the service cover can contact the flow nozzle on the filter

flange of the fuel pump. If this occurs over a sufficiently long period of time,

the nozzle may develop cracks.

Chronology:

June 2019 – as part of routine parts quality monitoring Porsche identified an elevated parts demand and began an investigation into the issue. This included warranty monitoring, and parts collection and analysis. Initial global analysis also indicated potential climate effects.

June 2019 to January 2020 - Porsche studied all known occurrences of the issue and applied them to a global "climate map" to help determine if the issue was isolated to certain regions. Porsche also studied the differences in vehicles in global markets with multiple confirmed occurrences to markets with fewer or no known occurrences.

Porsche conducted deeper part analysis to study the protrusion of a reinforcing rib of the service cover as the potential cause of the issue. Porsche also analyzed the vehicle population because some vehicle production periods did not appear to exhibit the issue.

On February 5, 2020 out of abundance of caution, to Porsche decided to conduct a voluntary safety recall for all affected vehicles.

Description of Remedy:

Description of Remedy Program: The service cover for the fuel pump will be reworked or replaced, and a

protective film will be applied to the fuel pump flange. In addition, the fuel

pump flange will be inspected and replaced if cracks are present.

How Remedy Component Differs The service cover remedy component will have improved tolerancing and/ from Recalled Component: or clearance (part number V04015005B).
