Dear Freightliner Sprinter Owner or Lessee,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Freightliner Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2019 Freightliner Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

MBAG determined that on certain Freightliner Sprinter vehicles certain screw connections on the exhaust gas recirculation (EGR) pipe (between the exhaust gas collection pipe and the exhaust gas recirculation controller) may not have been carried out according to specification. If the connecting screws are not tightened according to specification, the flange surface at the end of the EGR pipe may not be completely sealed. In that case, hot exhaust gas could leak into the engine compartment and potentially cause a fire and/or fire damage to immediately surrounding components.

What will your DEALER DO?

An authorized Freightliner Sprinter dealer will replace the affected screw connection and the flange seals on the exhaust gas recirculation pipe. **This service will be provided free of charge.** While the minimum repair time is **approximately 1 hour**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Freightliner dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time. You will not be charged for other service or repairs unless so requested.

Schedule an appointment immediately at your preferred authorized Freightliner Sprinter Dealer. See www.freightlinersprinterusa.com/freightliner/owners-resources/recall for the Dealer Locator. **Please mention you are scheduling an appointment to replace the affected screw connection and the flange seals on the exhaust gas recirculation pipe under Recall Campaign # 2020040009.** You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

We encourage you to sign up for recall alerts at www.nhtsa.gov/alerts. In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.
