Description of the Defect: This safety recall involves the throttle cable. The routing geometry of the cable

could allow water to collect within the cable. In certain environmental conditions, this could allow water to freeze. In rare cases, throttle function

could be impaired, specifically creating a stuck throttle condition.

Chronology:

On January 17, 2020, BMW became aware of a non-US incident in which the rider alleged a loss of throttle function, was subsequently involved in a crash, and reported a minor injury. Although BMW requested to inspect the motorcycle, the rider has not agreed.

BMW initiated an engineering review together with the supplier, and a field data analysis.

A review of field information suggested that three additional complaints may be related to impaired throttle function, but with no indications of a crash. The engineering review indicated that, due to the routing of the cable, water could collect within the cable near the throttle.

On February 5, 2020, another non-US complaint involving impaired throttle function was reported.

On February 6, 2020, BMW decided to conduct a voluntary safety recall.

Description of Remedy:

Description of Remedy Program: The final remedy is being developed.

In the interim, owners will be instructed to not ride in temperatures near and below freezing, not wash the motorcycle in the area near the throttle cable, and to avoid riding in rainy conditions. Owners will also be requested to visit their dealer to have the throttle cable dried. A warning label will be affixed to the motorcycle instructing owners to not ride in temperatures near and below freezing.

Owners will be notified by First Class mail and instructed to take their scooter to an authorized BMW motorcycle dealer to have the interim and final remedies performed for free. If this condition were to occur to a potentially affected motorcycle prior to this recall, the remedy would be covered by the BMW Motorcycle New Vehicle Limited Warranty program. Therefore, reimbursement for a pre-notification remedy re Part 573.13 and Part 577.11 is not necessary.
