Received a letter on 2/6/2020 from the Nebraska inspectors office informing us that they had completed a spot inspection of Heartland units at a local dealership and noted the smoke detector was not in the proper location. I called the dealer in question and confirmed with them that the smoke detector and CO2 detectors had been switched when installed. We notified the plant that produces the product and a change was made for the location of the smoke detector to ensure that is was in compliance. All units we put on hold and repaired that were still at Heartland. On 2/10/2020 the Heartland safety commitee held a meeting and voted to issue a recall on the placement of the smoke detector.
