#### <u>Fau t</u>

What s the specfc ssue with the affected vehces?

It has been dent f ed that a spec f c batch, due to nadequate we d ng by the supp er, of s de curta n a rbags may fa to nf ate n the event of a co s on dep oyment. Th s wou d reduce the effect veness of the a rbag system from protect ng the occupants n an event where a s de curta n a rbag dep oyment was ntended.

Why woud the a rbag fa to nf ate?

A nozz e used to d rect the gas from the storage unt (nf ator) nto the actua a rbag (cush on) was not adequate y we ded n a spec f c batch of components. In the event of an nadequate we ded nozz e, the gas may not be adequate y d rected nto the cush on to enable a complete dep oyment of the a rbag.

#### What a rbags are affected?

On y a very sma batch of Bent ey s de curta n a rbags are affected. Records h gh ght no dent f ed veh c e conta ns both eft and r ght hand defect ve components from the dent f ed batch.

#### Is this connected to any other reca?

Yes, Bent ey s aware of the same concern affect ng other veh c e manufacturers, who ut se the same supp er.

#### Wh ch other OEM s are affected?

We would not disclose this type of information; t is the responsiblity of the individual OEM s to perform their recal communication.

What repercuss ons does the fau t have?

Dur ng an nc dent, where the s de curta n a rbag dep oyment s ntended, the add t ona protect on th s s de curta n a rbag prov des may not be ava ab e, ncreas ng the r sk of njury.

What about the other veh c e a rbags?

The other a rbags ut sed n the veh c e are unaffected.

Have you seen any customer reports? D d t resut n an acc dent/ njury?

We have received no reports of any accidents or injuries associated with this recail.

What s the f x?

The so ut on s for author sed Bent ey reta ers to rep ace the potent a y affected curta n a rbag un t. Th s w take approx mate y four hours.

Can customers cont nue to dr ve the cars?

Yes, however, we encourage customers to arrange an appointment with their retailer as soon as possible.

Do I have to make an appo ntment?

Yes, that's mportant. Customers need to contact the r nearest Bent ey Motors reta er mmed ate y.

#### Veh c es affected

Wh ch veh c es and how many are affected?

Spec f c Bentayga mode s bu t between June 2019 and August 2019 and three veh c es, wh ch have had rep acement s de curta n a rbags f tted dur ng June and August 2019, are affected.

Cars bu t outs de these dates are not affected.

Why d d you not take act on sooner?

Once we were nformed of the potent a defect, we mmed ate y nvest gated the mpact on the Bentayga, ensured no further components were affected, prepared our own reta er network and then nformed author t es as soon as poss b e.

Why d d you cont nue to se cars even after you dent f ed the prob em?

We have on y a sma number of customers affected by this issue, with no reports of accidents or injuries. Cars built from August d d not contain components from the affected batch.


