This was found when she was adding new tire and wheel combinations into the system. I pulled all trailer files, investigated and found there were indeed errors on the copy of the placards on trailers with 16 inch Westlake tires on steel wheels. The placard had incorrect PSI listed at 110 instead of 80 as it should be.
