IMPORTANT SAFETY RECALL – NHTSA Recall No. 20V-151

This notice applies to Your Lamborghini Aventador SVJ with the VIN

Dear Lamborghini Owner, Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2020 Aventador SVJ Coupè and Roadster vehicles. Our records indicate that you are the owner of a vehicle in this recall.

What is the issue?

The affected vehicles might not have properly assembled internal door handle mechanisms. Over time the internal door handle may fail and the door cannot be unlocked from the inside, posing an entrapment risk.

If a door cannot be opened with the interior handle in the case of an emergency, it can increase the risk of injury for the driver or passenger. The outside handles operation is guaranteed by a different component and its functionality is not affected. Therefore, it is still possible to open the doors normally from the outside.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

What Do You Need to Do?

In the interest of the safety of your passengers, as well as your own safety, contact your authorized Lamborghini dealer immediately to schedule an appointment to have this important free repair performed as soon as possible. You can locate your nearest authorized Lamborghini Dealer at:

What will Lamborghini do?

We will replace the internal door handle for free. The repair could take up to 1 hour. We apologize for any inconvenience this recall may cause. Please bring this letter and your Service Booklet with you when you visit the dealer, so that we can make all necessary entries.

What if you are not the current owner of this vehicle?

You can update your vehicle ownership or contact information by filling out the enclosed document (Appendix A) and sending it to Lamborghini by following the detailed instructions present on it.

If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten days.


