Description of the Defect: Based on production data review, the passenger airbag score-line in the

instrument panel may potentially not have been performed according to

specification on three (3) vehicles worldwide.

Description of the Safety Risk: An incorrect passenger airbag score-line in the instrument panel may impact

airbag opening and inflation in case of a crash, or cause plastic parts to detach and enter the passenger compartment. This may lead to an increased risk of

injury in a crash.

Description of the Cause: Due to a faulty production tracking system in case of a detected production

error at the supplier, three (3) potentially faulty parts with a possibly missing passenger airbag score-line may have been delivered erroneously as OK serial

parts and therefore could be installed in customer vehicles.

"January 29, 2020: Supplier reported topic to responsible department at AUDI AG.

February 2020: Further research together with the supplier.

March-April 2020: Topic was reported and presented to the Audi Product Safety Committee. Additional analysis was tasked in order to identify root cause, clarify supply chain and processes. Risk analysis was performed and possibly affected production lots and vehicles were identified.

May 6, 2020: Out of an abundance of caution the Audi Product Safety Committee makes the determination of a potential safety defect and decides a worldwide recall.

Description of Remedy:

Description of Remedy Program: The vehicle will be inspected regarding the serial number of the

instrument cluster. If the vehicle is equipped with one of the three (3) potentially affected parts, the instrument cluster will be replaced. Because affected vehicles are within the warranty period, Audi will not offer a

reimbursement program under this recall.

How Remedy Component Differs "Only three (3) parts are affected, and they can be clearly identified

from Recalled Component: through the serial number on the part. The records for all other parts show

that they have been manufactured according to specification.
