Problem Description:

Forest River, Inc. (Forest River) is recalling certain 2019-2020 Coachmen Mirada and Pursuit Class A motorhomes. The gasoline-powered generator fuel supply hose may leak.

Consequence:

A fuel leak in the presence of an ignition source can increase the risk of a fire.

Remedy:

Forest River will notify owners, and dealers will inspect the fuel hose, replacing it if necessary, free of charge. This recall is expected to begin July 6, 2020. Owners may contact Forest River customer service at 1-574-825-8212. Forest River's number for this recall is 310-1168.

NHTSA is missing critical, required information for this safety recall. This information must be supplied through the NHTSA Recalls Portal within 5 working days of confirming its accuracy:

- An identification and description of the risk to motor vehicle safety reasonably related to the defect or noncompliance (49 CFR 573.6 (c)(5)), specifically it should call out the increased risk of a fire.

We have received Forest River's proposed owner notification letter and it has been approved on June 2, 2020. Please upload a final copy with distribution dates once mailing begins.

Please be reminded of the following requirements:


Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
