Description of the Defect : Mercedes-Benz recall 20v180 - The Operators manual for the sprinter chassis with automatic transmission does not correctly specify certain conditions under which the automatic parking function ("Auto-P) operates. The manual describes certain functions, which would automatically engage the park position "P" if (1) the driver opens the seat belt or(2) the driver leaves the seat when the vehicle is stationary or driving at a very low speed. However, this functionality is not available in the sprinter chassis

MB could not provide this information. Jayco researched and created scope of affected products from production records. 6-1-20 MB Recall discussed at WIRC meeting and elevated to CPAC for further review of details. 6-3-20 CPAC reviewed and then elevated to Safety Steering Committee , recommending a pass through chassis recall. 6-4-20 SSC voted that a pass through chassis recall was required.
