Incident:	The Operator's Manual for the Mercedes-Benz Sprinter Chassis with automatic transmission does not correctly specify certain conditions under which the automatic parking function ("Auto-P") operates. The manual describes certain functions, which would automatically engage the park position "P" if (1) the driver opens the seat belt or (2) the driver leaves the seat when the vehicle is stationary or driving at a very low speed. However, this functionality is not available in the Sprinter Chassis. Should a customer rely on the Auto-P function as described in the Manual, the motorhome may rollaway or movement is possible.
