SUBJECT: Important Safety Recall # 20V345

This notice applies to Prestige step deck semi-trailers

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Lode King Industries has determined that a defect which relates to motor vehicle safety may exist with your Prestige semi-trailer that could affect your safety.

Details are as follows:

- The name of the company giving notice is: a. Triple E Canada Ltd. **D.B.A. Lode King Industries** Box 1146 135 Canada Street Winkler, MB R6W 4B2 Phone (204) 325-4345
- Trailer VIN: 2LDSD5329MG069431 b. Make: Prestige Model: SDG53-2 Model Year: 2020
- c. This defect is that an incorrect load rating decal was applied to the trailer when it was manufactured. The load rating information displayed on this decal exceeds the strength of the main beams on this unit. This decal is located on the main beam of the trailer frame, beside the VIN plate containing the trailer serial number. See the accompanying photograph that illustrates this location.
- The safety risk is a structural failure if the trailer is overloaded, which could cause a d. loss of control and increase the risk of a crash.



- e. The corrective action for this defect is to remove the existing, incorrect decal and replace it with the correct load rating decal.
- f. Do not overload the trailer to minimize the risk of a failure of the trailer frame. Follow the load rating information shown on the load rating decal below.
- g. This corrective action can be accomplished at your authorized Prestige trailer dealer at no cost to you. We ask that you contact your dealer and make arrangements to get the trailer into their service shop for the work to be carried out. A half hour of shop time is allowed to make this change. The correct load rating decal for your trailer is illustrated below.
- h. Any trailer lessor receiving this recall notice should forward a copy of this notice to the lessee within 10 working days. If you know the current owner or operator, please forward this letter to them.

Our point of contact here at Lode King for the Recall will be the Mr. Randall Siemens, Customer Service & Warranty Manager.

If Lode King or its dealers do not repair the defect free of charge and within a reasonable amount of time, you may notify the Administrator of the National Highway Traffic Safety Administration, 1200 New Jersey Ave., SE., Washington, DC 20590; or call the toll-free Vehicle Safety Hotline at 1-888-327- 4236 (TTY: 1-800-424-9153); or go to http://www.safercar.gov.
