### **Description of Defect:**

Description of the Defect: As per Daimler Vans USA, LLC (DVUSA) recall # 20V181 a recall is being issued

on certain 2019 Freightliner Sprinter and Mercedes-Benz Sprinter vehicles. The rear part of the fender liner on the front axle may contact and chafe the

brake hose, possibly resulting in a loss of brake fluid.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: If the distance between the fender liner and the brake hose is not sufficient,

the front wheel suspension could make contact with the brake hose, which could lead to chafing of the brake hose and the loss of brake fluid. Over time, if

the operator ignores the brake fluid warning indicator and continues to operate the vehicle until the brake fluid runs dry, this may extend the braking

distance and increase the risk of a crash.

## **Chronology:**

In early 2020, MBAG initially became aware of a report from a customer in the United Kingdom where the red brake fluid warning indicator displayed, indicating a brake fluid leak. MBAG launched an investigation to understand whether this individual report was indicative of a broader issue. In February - March 2020, MBAG's

investigation included a detailed review of the parts and components in the front axle wheel housing, including tolerances in the mounting process, a materials analysis, geometry analysis and tire sequencing. The investigation found certain fender liner were deformed. Sprinter plants were advised to inspect all vehicles still located at the plant and to check and correct them if necessary.

On March 18, 2020, MBAG determined that a safety risk could not be ruled out and decided to initiate a recall campaign.

A - 1 - On 7.24.20, OCC received an electronic VIN notification from Daimler and found additional VINs, not present in the first notification that need to be included in the scope. On 7/28/2020 amended recall, notify all added consumers.

A – 2 - On July 30, 2020 Forest River's Office of Corporate Compliance (OCC) received information from our manufacturing plant that a vehicle which was listed as still in Forest Rivers possession at the time of the recall filing, had shipped to a dealer. On August 3, 2020 - Amended recall to add 1 vehicle - model FR2401QSD. Which now brings the total US population to 522 from 521. Additionally FR is notifying the owner of this 1 amended vehicle

## **Description of Remedy:**

Description of Remedy Program: Forest River will notify owners, and Mercedes-Benz or Freightliner

Sprinter dealers will inspect and replace the brake hoses, as necessary. Additionally, the fender liners will be modified. All services will be
