## IMPORTANT SAFETY RECALL 2020080016

This notice applies to your vehicle, VIN: Update ESP Control Unit Software NHTSA Recall #20V395

A remedy is available for your vehicle.
Schedule an appointment with your authorized Mercedes-Benz dealer as soon as possible.
This repair will be provided free of charge.

Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2019-2020 C-Class, GLC-Class, and GT-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?	On certain MY 2019-2020 C-Class, GLC-class, and GT-Class vehicles, the Electronic Stability Program ("ESP") control unit software might not meet current production specifications. Incorrect software could lead to the unavailability of certain ESP functions, and cause the system to not react properly to certain driving situations, increasing the risk of a crash.
What will your DEALER DO?	An authorized Mercedes-Benz dealer will update the ESP software on the affected vehicles. <u>This service will be</u> <u>provided free of charge.</u> We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be approximately <b>30 minutes</b> , your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle which may increase the required working time.
What should YOU DO?	For additional information and to schedule an appointment, please contact your preferred authorized Mercedes- Benz dealer at your earliest convenience. To locate authorized dealers see <u>www.MBUSA.com/recall</u> . <b>Please</b> <b>mention you are scheduling an appointment to update the ESP software on the affected vehicles under</b> <b>Recall Campaign # 2020080016.</b> You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

The Mercedes-Benz dealerships remaining open for recall repairs and service are closely following the guidelines set forth by the CDC. <b>Free</b> Mobile Repair at your home or business as well as vehicle pick-up and delivery may be available. Your preferred authorized Mercedes-Benz dealer can confirm availability.
