Mercedes-Benz AG ("MBAG"), the manufacturer of Freightliner Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2019 Freightliner Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

| What is the CONCERN? | MBAG has determined that on certain Freightliner Sprinter vehicles, on the left and right side, an incorrect leaf spring shim was installed between the rear axle and the leaf springs. For the affected vehicles with the incorrect leaf spring shim mounted, it cannot be completely ruled out that there could be negative effects on the driving behavior in highly dynamic driving situations. In a worst-case scenario, this could increase the risk of a crash. |

| What will your DEALER DO? | An authorized Freightliner Sprinter dealer will replace the leaf spring shims on both sides, install new spring brackets and its fasteners, check the rubber spacers for wear, replace them if necessary and then adjust the headlamps to the new zero position. While the minimum repair time can be up to approximately 1.5hrs, your dealer can provide you with a better estimate of the overall time for this service visit.
