The affected VIN's will now be marked with the recall campaign number 0000348500. The initial campaign number "STOP340006" will be removed in the next 24hours. Vehicles can be released for sale after performing the attached inspection and/or repair.

In order to determine if a specific vehicle is affected by this campaign first verify the vehicle VIN in AIR (Aftersales Information Research). Based on the response of the system, either proceed with the repair or take no further action. Please note, stop codes may not appear in DCS Vehicle History Check <u>or sales systems</u> until 24-72 hours after stop is announced, therefore AIR is always the recommended method for determining open campaigns and vehicle stops.

SITUATION

The front brake calipers may show slight sweat marks or isolated drops of brake fluid. Although this low-pressure leakage has been shown to have no effect on brake performance, BMW Motorrad is conducting a non-compliance recall to inspect each vehicle as the front brake calipers do not meet a Federal Regulation.

Customers will be notified by BMW Motorrad USA via First Class mail advising them of this recall. Customers will be asked to schedule an appointment with an authorized BMW Motorrad dealer to have the inspection performed. In the case of vehicles that have not yet been delivered, the Technical Campaign must be carried out **before delivery** to the customers. Vehicles have been marked with a delivery stop.


A TSARA case must be created for any vehicle requiring a caliper replacement. Within the case, <u>clear pictures</u> of the leakage must be included as well as pictures of the DOT matrix code. TSARA will evaluate the case <u>and a parts order will be placed for your dealership by BMW</u>. The TSARA case number will be used as the order reference number.
