#### **Description of Defect:**

Description of the Defect: The rear spoiler may not have been produced according to supplier

specifications. During a specific and limited production period, a deviation in the adhesive curing process may have occurred. The deviation could allow the adhesive to not cure properly and, therefore, cause an inappropriate bonding between the spoiler and its mounting plate. Over time, the spoiler could

become loose and eventually detach from a moving vehicle.

#### **Chronology:**

On July 14, 2020, a rear spoiler that appeared to be loose was noticed during vehicle assembly. Additional vehicles at the assembly plant were checked and several more with loose spoilers were identified. An engineering review was initiated, and the supplier was contacted.

Supplier records were reviewed which indicated that a deviation in the production process had occurred during a specific and limited time period. During this period, due to an issue with the adhesive system's thermocouple, replacement parts were used; however, it was determined that these replacement parts improperly influenced the temperature at the system's mixing head. As a result, the adhesive could not cure properly and, therefore, could cause an inappropriate bonding of the spoiler.

Vehicle assembly information and supplier production records were reviewed to determine the number, and production dates, of potentially affected vehicles.

On August 12, 2020, BMW decided to conduct a voluntary safety recall.

BMW has not received any reports, nor is BMW otherwise aware, of any accidents or injuries related to this

issue.			

## **Description of Remedy:**

Description of Remedy Program: The rear spoiler will be inspected and, if necessary, replaced.

Owners will be notified by First Class mail and instructed to take their vehicle to an authorized BMW dealer to have the remedy performed for free. If this condition were to occur to a potentially affected vehicle prior to this recall, the remedy would be covered by the BMW New Vehicle Limited Warranty program. Therefore, reimbursement for a prenotification remedy re Part 573.13 and Part 577.11 is not necessary.
