Description of the Defect :	The Motor homes included in this recall were manufactured with the Spyder Control G9 ECM with inadequate over voltage and cut off relay. The G9 ECM can handle voltage up to 18 volts. Over voltage can damage components on the board which can result in thermal flammability.

Description of the Safety Risk :	If damaged components are allowed to conduct higher voltage , it could result in fire, which could result in property damage, injury or death.
Description of the Cause :	The voltage suppression device were undersized for voltages that you see in the field.
	There are no warning signs. Jump starting the vehicle with the incorrect sized jump pack or battery charger can result in over load damage.

This device will be installed between the battery input and the G9 ECM. A web page will be set up for shipping of the parts. Reimbursement will be through the normal warranty claim process.
	The remedy to the G9 ECM will include an additional over voltage protection device placed between the G9 ECM and the battery input.
