Subject: Stop Sale Added Population for Upcoming Safety Recall A202307260

Models: 2020-2021 Buick Encore GX, 2020 Cadillac CT4, CT5, XT4, Chevrolet Corvette, and 2021 Trailblazer

To: All General Motors Dealers

STOP DELIVERY ORDER

On September 24, 2020, GM dealers were notified via GlobalConnect Message GCUS-3-1921 regarding the Stop Sale for Upcoming Safety Recall A202317260. Please be advised that an additional population of 486 vehicles has been discovered after careful VIN analysis of this field action.

Effective immediately, stop the delivery of certain 2020-2021 model year Buick Encore GX, 2020 model year Cadillac CT4, CT5, XT4, Chevrolet Corvette, and 2021 model year Chevrolet Trailblazer vehicles in new or used vehicle inventory. General Motors has notified the National Highway Traffic Safety Administration (NHTSA) about an upcoming safety recall that involves these vehicles. The GM recall number is A202307260.

It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification until the defect is remedied.

Until further instructions are received, involved vehicles that are in dealers' possession (new or used vehicle inventory, GM Certified Used, courtesy transportation vehicles, dealer shuttle vehicles, etc.) must be held and not delivered to customers, dealer-traded, released to auction, used for demonstration purposes or any other dealer use. All GM Certified Used vehicles currently in the dealers' inventory within the Certified Pre-Owned Inventory System (CPOIS) will be de-certified.

The Investigate Vehicle History (IVH) screen in the Global Warranty Management (GWM) system will be updated for this upcoming recall on September 24, 2020. This action has been taken to assist dealers with determining which vehicles are involved so they can properly respond to customer inquiries.

A list of the added vehicles in dealer new inventory is attached to this message. The original list sent on September 24, 2020 of vehicles in dealer new inventory is also attached to this message for your reference. It is sorted by dealer Business Associate Code (BAC) for easy reference. Your dealership's BAC will not be listed if none of the involved vehicles are currently in your new vehicle inventory. A file identifying involved vehicles in dealer used inventory will be published in GM GlobalConnect, under the Service tab in Field Action Inventory Reports.

Question and Answer Document (Q&A)

Attached to this message you will find a document that addresses the ten most likely questions customers may have regarding this Safety Recall. Please use this information as an aid to confidently answer customer concerns.

Until the recall bulletin is released, the Investigate Vehicle History (IVH) screen in the Global Warranty Management (GWM) system will display "N/A" under Release Date and "Incomplete – Remedy not yet available" under Status. This means the required repair is not yet available and dealers should not attempt to perform any repairs.

We are working with the supplier to obtain the required parts as quickly as possible. When a sufficient quantity of parts are available, the recall bulletin will be released and dealers can begin repairing vehicles.
