Description of the Noncompliance : Incorrect tire and GAWR information on labels.

Labels note ST205/75R14 load range "D" and GAWR of 3,000lbs when correct for these units is ST225/75R15 load range "E" and GAWR of 3,500lbs.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : NR

Description of the Safety Risk : Consumer may inadvertently replace tire/s with incorrect size and overload the trailer - creating drivability issues that may result in a crash.

Description of the Cause : A special build of X213 - Baja Type travel trailer with different axles and tires was not taken into account when noting the tire information and GAWR of the units.

9-18-2020 Incident reported by Engineering as preparing set up for labels for second run of 2021 Jay Feather X213 travel trailers - Baja type - with different axles and tires - they noticed error in the label information. Investigation found error made in the first and only round of the X213 travel trailers with different axles and tires. 9-11 Incident elevated to CPAC for review - Affected units retail sold - recall is required 9-24-2020 Safety Committee reviewed and agreed that recall was required.

Description of Remedy :

Description of Remedy Program : Place new labels on affected travel trailers noting ST225/75R15 Load range "E" tires and GAWR of 3,500lbs. Correct labels will be enclosed with the Retail Notification letter with instructions how to proceed. The current owner may take to a Jayco dealer to place the corrected labels on the travel trailer at no charge.

How Remedy Component Differs from Recalled Component : Incorrect Labels note tires as ST205/75R14 load range "D" and the GAWR of 3,000lbs
