# **Chronology:**

During component crash tests conducted in mid-2018, the crash lock system allowed the center console compartment door to open during a simulated rear-end collision. Subsequently, extensive tests were carried out by MBAG and its supplier. These investigations showed that a plastic latch was too rigidly designed, which caused the crash-lock mechanism to malfunction. On December 12, 2018, MBAG decided that the regulatory requirements in South Korea regarding the crash lock system could not be reliably met.

At that time, the MBAG's records indicated that only vehicles in South Korea were affected by this issue and a foreign recall report under 49 C.F.R. § 579 was submitted in the United States.

During the course of internal quality assurance measures conducted at the production plant in Tuscaloosa, MBAG identified a plant action involving a small number of vehicles intended for the US market that had been prepared but not implemented. As a consequence, 7 potentially affected vehicles left the vehicle plant in the USA. On September 25, 2020 MBAG decided to supplement the recall decision from 2018 for the 7 additional vehicles.
