Subject: TBB Minotour Wheelchair Lift Interlock

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Trucks North America LLC (DTNA), on behalf of its wholly owned subsidiary, Thomas Built Buses, Inc., has decided that a defect, which relates to motor vehicle safety, exists on specific Model Year 2009-2021 Thomas Built Buses Minotour buses manufactured January 23, 2008, through June 4, 2020, and equipped with an optional wheelchair lift.

On certain buses, the driver may be able to release the park brake and shift the transmission out of Park and into a drive gear with the wheelchair lift deployed. If the vehicle is moved while the wheelchair lift is in operation, there is an increased risk of injury.

The wheelchair lift interlock harness will be replaced.

Please contact your local Thomas Built Buses dealer to arrange to have the Recall performed and to ensure that parts are available at the dealership. To locate an authorized dealer, search online at

If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days.
