**Descriptive Information :** Recall population was determined by the component manufacturer (Dometic). Recalled product involves specific cooktop/ranges manufactured by Dometic within a serial number range. Other products used different cooktop/range assemblies from other manufacturers. A total of 352 model year 2020 Transcend vehicles are involved in this recall.

**Description of the Defect :** According to Dometic, a gas leak may occur at the joint between the gas saddle valve for the burners and the manifold under the burner surface.

FMVSS 1 : NR

FMVSS 2 : NR

**Description of the Safety Risk :** In the event of a gas leak, the potential exists for a fire.

**Description of the Cause :** Per Dometic, the leaks are a result of field adjustment and/or over tightening of securement bolt for the saddle valve to manifold connection.

**Identification of Any Warning that can Occur :** A gas smell may be present.

### Chronology :

Grand Design was notified by Dometic Corporation of the defect in a recall letter received 11/16/20. A copy of the Part 573 filed by Dometic was obtained on 11/18/20, identifying the recall as 20E-071. Grand Design pulled all purchase & build records to identify the number of affected vehicles. The recall population was identified on 11/23/20. Additional information regarding the defect and remedy was requested and received from Dometic on 12/7/20. As the final stage manufacturer, Grand Design decided on 12/7/20 to file our own Part 573 in accordance with NHTSA requirements.

### Description of Remedy :

Description of Remedy Program : Dometic will be providing a remedy kit that includes gaskets, washers, thread locker bolts and orange stickers. Grand Design will distribute these kits directly to dealers for recall completion. Owners who have paid to have this service performed will be reimbursed by Grand Design.

How Remedy Component Differs from Recalled Component : Unknown. Information not provided by Dometic.

Identify How/When Recall Condition was Corrected in Production : Grand Design no longer uses this component in production. Last use was January of 2020.
