Description of the Defect: The brake pedal may not have been manufactured according to the required

specifications.

Description of the Safety Risk: In unfavorable conditions, the brake pedal plate may deform in case of an

emergency brake situation with full impact loading onto the brake pedal and full detachment of the brake pedal plate cannot be completely ruled out. If the brake pedal plate detaches, the driver would still be able to operate the brake pedal, however the contact area for the driver's foot would be reduced in size,

increasing the risk of a crash.

Description of the Cause: Due to a manufacturing error at the sub-supplier, it is possible that the joint

connection between the brake pedal and the brake pedal plate was not welded

correctly in individual cases.

#### **Chronology:**

August 24, 2020: The supplier noticed a potential welding issue and reported it to AUDI AG. Investigation regarding root cause, consequences and affected parts began including screening and separation of affected parts.

September 05, 2020: Start of bench tests to assess failure mechanism, probability and consequences.

November 03, 2020: Topic is reported to Product Safety Committee based on results and findings from the investigation.

November 04 - December 08, 2020: Internal discussions and presentations to Product Safety Committees within the Volkswagen Group.

December 09, 2020: The Audi Product Safety Committee determines that, in individual cases, the brake pedal plate may deform if the brake pedal is operated with full impact load in case of an emergency braking and the brake pedal plate fully detaching cannot be completely ruled out. Therefore a worldwide recall for the potentially affected vehicles is decided.

### **Description of Remedy:**

Description of Remedy Program: At no cost to owners, dealers will inspect for a correct weld at the joint

connection between the brake pedal and the brake pedal plate. If the weld is insufficient, the entire brake pedal will be replaced. Audi will not offer a

reimbursement plan under this recall.

Replacement parts have been produced after welding issues have been

solved and monitoring had been improved at the sub-supplier.

Identify How/When Recall Condition In CW 28/20 a new sub-supplier was introduced in the production process

was Corrected in Production: of the brake pedal. After determination of the welding and monitoring issue in CW 35/20 the sub-supplier implemented a 100% check of the parts before delivery. In the future a camera-based monitoring of the

welding process is planned at the sub-supplier.
