SL2065 steerable lift axle suspensions systems may be equipped with lower rear pivot cap screws that are not long enough to sufficiently engage the

locking feature of the corresponding nuts."

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: Reference 20E055. "In some cases, the above-referenced condition may cause

a loss of clamp load of the corresponding pivot joint. Extended use of the suspension in this condition can result in the fracture or loss of the cap screw

and related

washers and nut. This can further result in foreign object debris on the roadway, increasing the risk of a crash and/or injury. W&C has not received

any field reports of accidents due to a cap screw fracture or loss."

Description of the Cause: Reference 20E055. "W&C has determined some of the affected lower rear pivot

cap screws that were manufactured at the extreme low side of the length tolerance specification may not sufficiently engage the locking feature of the

corresponding nuts during installation."

Identification of Any Warning Reference 20E055 "Possible warning signs that may appear before a lower rear

that can Occur: pivot cap screw fracture or loss include an insufficient number of cap screw

threads extending beyond the end of the pivot nut, a missing pivot nut, failure of the suspension to lift or lower properly, and suspension noise and vibration."

June 24, 2021 Volvo Group Purchasing receives information, Notice sent to Aftermarket part sales team. June 24, 2021 Volvo Regulatory Affairs follows-up with Aftermarket parts sales Vice President. Aftermarket Parts Team investigates and determines that there is no record of receiving the information. See notes for additional information.

June 24, 2021 Volvo submits defect report to NHTSA.

Description of Remedy:

Description of Remedy Program: W&C will notify its affected vehicle OEM and aftermarket equipment

installer customers of this issue, and recommend they and/or their applicable customers who own any vehicles equipped with the subject SL2065 suspension systems to: (1) inspect the suspensions and determine whether the lower rear pivot cap screws meet the criteria for threads extending beyond the respective nuts; (2) if such criteria are not met, contact W&C to order a replacement lower rear pivot fastener service kit free of charge; and (3) use W&C's instructions for installing such replacement fasteners. W&C will manage and track all orders it receives for replacement service kits, as well as its shipments of such kits. W&C will

provide a standard allocation of labor hours for installation of the

replacement service kits.

Volvo will notify customer. Pre-notification repairs, if applicable, will be addressed according to the Volvo Group Pre-notification remedy plan on

file with NHTSA.
