**Descriptive Information :** As outlined previously, S&S has not purchased warning devices from Ningbo Fuding Industrial Co. since November 2019 and we currently have no Ningbo Fuding Industrial Co. warning device inventory in stock within any of our locations. We do not dispute the findings of report 125-STIS-21-001 and have already taken precautionary measures to ensure compliance with all DOT regulations with our new warning device supplier

### Description of Noncompliance :

**Description of the Noncompliance :** See your report 125-STIS-21-001. In summary the triangle kits was out of compliance. Based on your report the triangle kits did not have the proper marking.

**FMVSS 1 :** 567 - Certification

**FMVSS 2 :** 125 - Warning devices

**Description of the Safety Risk :** There were 2 areas of non-compliance with the triangle kits:

1. Marking failure - No safety risk
2. Reflex Color Requirements - We cannot define any potential safety risk of the reflex being outside of the NHTSA standard but the fluorescent orange material being acceptable according to the NHTSA guidelines. If there is data available which outlines the safety risk of having the reflex outside of the NHTSA standard, but the fluorescent Orange Material within the NHTSA's

acceptable level, then we can use data to help determine any potential safety risk. Without any proper data outlining the potential safety risk; we cannot hypothesize on any potential safety risk.

### Chronology :

April 18, 2019 – We shipped order# 3068460 to Martins Peterbilt; which included the triangle kits in question. We could determine the order number via the pictures provided by NHTSA.

April 29, 2021 – Martins Peterbilt sent us the failure letter they received addressed to them from NHTSA

June 3, 2021 – S&S received a letter and test results from NHTSA stating: 1) The triangle kits did not have the proper manufacturer marketing 2) The red reflex reflective material was outside of the acceptable range bounded by the spectrum locus as defined by NHTSA.

June 16, 2021 – We completed calling all the customers which bought the triangle kits in questions, to ensure there were no more of these triangle kits in circulation.

June 23, 2021 – S&S responded to the questions posed in the document we received from NHTSA; the response was sent to Leroy Angeles @ NHTSA. The responses we provided were in the accordance with the timeline provided by NHTSA

Aug 3, 2021 – We got access to the NHTSA portal and all information since this date has been put into the portal.

## Description of Remedy :

Description of Remedy Program : 1. We have already called all the customers which procured these kits.  
2. We will send the form letter outlining the issue to the customers.  
Timeline: Completed by 11.15.21  
3. We full reimburse any customer which has any of these triangle kits in stock and get the out of compliance triangle kits back.  
4. We will pay the freight back for any customer which still has any of these triangle kits  
5. Once we receive the out-of-compliance triangle kits back, and fully reimburse the customer, we will destroy the out-of-compliance triangle kits to ensure they are removed from circulation.
