## **Problem Description:**

Cooper Tire & Rubber Co. (Cooper Tire) is recalling certain Cooper CS5 Grand Touring 225/55R17 and Mastercraft LSR Grand Touring 225/55R17 tires with DOT codes 2920 through 0121. The tires may have low tread gauge in the shoulder slot area which could cause tread separation and sidewall failure.

# **Consequence:**

A sidewall failure may cause the tire to rapidly deflate, increasing the risk of a crash.

## **Remedy:**

Cooper Tire will notify registered owners, and dealers will inspect and, if necessary, replace the tires, free of charge. Copper Tire plans to begin notification no later than April 22, 2021. Owners may contact Cooper Tire customer service at 1-800-854-6288. Cooper Tire's number for this recall is 177-2. Note: This recall supersedes 20T-017 and any tires recalled under 20T-017, but not yet replaced, are now included in this safety recall.

We have received Cooper Tire & Rubber Co. proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
