## **Description of Defect:**

Description of the Defect: While sweeping lightweight material such as leaves, pine needles or large

amounts of paper, an excess of these materials can build up in front of the sweeping head if the sweeper is not adjusted to allow them to pass into the pick-up area. In such instances, these materials can come in contact with the chassis exhaust system. In such systems with a short tailpipe, the buildup of

materials against the exhaust system may lead to a fire.

Description of the Safety Risk: If lightweight materials accumulate against the exhaust system and are not

drawn up into the pick-up area, this poses the risk of a fire.

Description of the Cause: Some of the sweepers in the affected population were manufactured without a

these sweepers.

## **Chronology:**

On October 15, 2021, Schwarze Industries, Inc. ("Schwarze"), a subsidiary of Alamo Group, was notified by a customer of a vehicle fire involving an A-Series CNG sweeper.

On October 28, 2021, Schwarze, with the support of a third-party fire investigator, examined that sweeper.

On November 18, 2021 Schwarze was notified by a dealer of a second vehicle fire involving an A-Series CNG sweeper.

On December 14, 2021, Schwarze inspected that second sweeper.

In the course of its investigation into both events, Schwarze examined manufacturing records for the A-series CNG sweepers.

On December 17, 2021, Alamo Group decided to conduct a voluntary safety recall to install a tailpipe extension to any A-Series CNG sweepers in the affected population that do not have a 56" tailpipe.

As of December 17, 2021, Alamo Group is aware of no warranty claims and no injuries related to this issue. As to field or service reports, as noted above, Schwarze received on October 15, 2021, a customer report of a fire and received on November 18, 2021, a dealer report of a fire.

### **Description of Remedy:**

Description of Remedy Program: Schwarze will provide dealers, free of charge, a kit (No. 206B93) to extend the exhaust tailpipe for all affected vehicles, so that the tailpipe extends the exhaust outlet beyond the backside of the sweeping head.

> A local Schwarze-affiliated dealer will install the kit at no cost to the vehicle owner.

In addition, if this issue was identified and remedied on an affected sweeper prior to this campaign, the owner of the sweeper may be eligible for reimbursement of the costs incurred for such remedy.

Identify How/When Recall Condition No A-Series sweepers have been manufactured between July 1 and was Corrected in Production: December 15, 2021. Schwarze updated drawings and control documents on December 15, 2021. All units manufactured after this date will be fitted with the proper 56" tailpipe and production protocols have been upgraded to better ensure the 56" tailpipe is installed. The addition of this tailpipe extension has been added as a printed line to the sales order, which is used in final inspection, and has been added to Schwarze's CTQ (Critical To Quality) in-process inspection check list.
