# IMPORTANT SAFETY RECALL

2021 Elantra, 2020 – 2021 Santa Fe, and 2021 Sonata Windshield Mounting

#### Dear

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect, which relates to motor vehicle safety, exists in certain 2021 Elantra, 2020 – 2021 Santa Fe, and 2021 Sonata vehicles in the U.S. and Canadian markets. Hyundai is initiating recall campaign 216, a safety recall, to repair a condition involving the windshield assemblies. Hyundai is conducting this action to ensure the safety of its vehicles for Hyundai customers. Our records indicate that your vehicle is affected by this campaign.

## What is the problem?

The subject vehicles may have been assembled with non-conforming clear coat paint which could lead to inadequate adhesion of the front windshield to the vehicle structure. A windshield that is not adequately retained may detach in a crash, which could increase the risk of injury.

## What will Hyundai do?

Your Hyundai dealer will perform a removal of the front windshield panel and reinstall it with properly formulated material per standard repair procedures. This procedure will be performed at **NO CHARGE** to you.

#### What should you do?

The actual time required to perform this procedure on your vehicle may take 1 – 2 hours. Therefore, we recommend scheduling a service appointment to minimize inconvenience.
