Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2021 Redwood Fifth Wheels. As a result, Keystone RV is conducting a safety recall.

Reason for This Recall

It has been decided that the vehicles in the recall population have a Dexter axle using a substitute spring with U-bolts that were not properly torqued. Under certain conditions during travel, if the improperly torqued U-bolts come loose, there is an increased risk of the axle sliding back on the spring, which could result in poor vehicle handling and/or vehicle crash. The vehicles included in the recall are:
