## **Important Reminders**

The new HD part numbers 84594241 (air bag kit) and 84594242 (bracket) must ONLY be submitted with the new labor code (9105716) AND with job card date of <u>June 28, 2021 or later</u> to avoid claim rejection. Vehicles repaired with the new part number 84594241 **MUST** have the serial number recorded when submitting the claim.

Dealers submitting for the previous HD part number 84255088 with a job card date **PRIOR to June 28, 2021** must use the previous labor code (9105360). Vehicles repaired with the previous part number 84255088 do not require recording of the serial number when submitting the claim for Priority Group 9.

## **Global Warranty Management (GWM)**
