Subject: Recall for inspection of Dexter Axle hub for potential missing inner bearing

Dear Jared Fisher,

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

PJ Trailers Manufacturing, Inc. (PJ Trailers), has concluded that a defect, which relates to motor vehicle safety, exists in certain 2021 PJ Trailers Models (C4, U6, U8, UC, UL). A failure of the hub subassembly on the Idler Axle from Dexter Axle could result in accidental damage to include personal injury, death and/or property damage.

Your trailer has been identified as one that is included in this recall. You are advised not to use the trailer for any purpose and to immediately contact PJ Trailers to schedule the required inspection and potential axle replacement (only performed if the inspection fails). Please contact PJ Trailers Warranty Team by phone at (888)330-8106 or by email recall@pjtrailers.com immediately to schedule the inspection.

The defect will be remedied by your authorized PJ Trailers dealer or representative by inspecting the axle hub for the inner bearing presence. If the inspection fails (i.e., inner bearing is missing) the dealer will replace the axle. The inspection will take approximately 10 minutes to perform and if the inspection fails, the axle will be replaced, which will take about 1 hour to complete. However, additional time may be required depending on how dealer appointments are scheduled and processed. To make the appointment to schedule the necessary inspection and potential axle replacement, which will be performed at no charge to you, please do the following:

Call PJ Trailers Manufacturing, Inc. toll-free at (888)330-8106 or via email recall@pjtrailers.com for the location of your closest PJ Trailers dealer, or authorized representative, who will perform the inspection and potential axle replacement. You should call the same number if you have any problem obtaining the needed repair. DO NOT USE THE TRAILER FOR ANY PURPOSE.

If you had the axle replaced before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. For more information contact PJ Trailers at (888)330-8106 or via email recall@pjtrailers.com.

Upon completion of the necessary inspection and potential axle replacement, the dealer or PJ Trailers authorized representative will notify PJ Trailers Manufacturing, Inc. that your trailer has been inspected and if it required the axle to be replaced or not.

If you no longer own the subject trailer, please provide PJ Trailers with the new owner's information (if known), either by mail to the address listed above, via email **recall@pjtrailers.com** or by fax to (903)785-6898. If the new owner information is unknown, simply notify PJ Trailers that you no longer own the subject trailer.

If you believe that PJ Trailers Manufacturing, Inc. has failed or is unable to remedy the potential defect without charge within a reasonable time, you may submit a complaint to:
