Freightliner Custom Chassis was notified and began researching the issue. Freightliner contacted Newmar on 02/10/2021 and recommended that Newmar proceed with a recall for this defect. On 02/17/2021, Newmar is giving notice to NHTSA of a potential safety

defect.
